membership make-up and the details of the various activities. I will summarize here the general points and some personal conclusions.

The club has today 254 members of which 185 are active members. One quarter of the active members are new. This is a sign of health and shows that we offer an attractive Club life. In 2000, a series of new activities was introduced: America's Cup Night, Easter Cruise, Match-Race, new Windsurfs, Special 1st Thursday of the month with introduction for newcomers, Photo contest. I have seen many young people in Versoix, just on the few Thursdays I was there.

The recruitment of new members and their introduction to sailing is a crucial part of our activity. We have started a process of clarification of the rules for enrolment to our most popular courses and to the rules for passing a test. The latter is especially important for our experienced new-members that want to start to use the boats right away. Again, it is important to find the right balance between their enthusiasm and the need of verifying their level, before giving them access to the boats.


The boats in general were in good shape and available for sailing. A special case is the catamarans, where the maintenance time was long, especially for Mystere 7 that was seriously damaged in July and was not repaired during the season.

The statistics on the use of the boats depend on how diligent are our members in compiling the reports. A nice point in the statistics is that the Caravelle has been enjoyed for private use as much as the Lasers and the Iso. There is a clear increase in the use of our keelboats. The logs of Ynglings and Mic-Mac show some 140 outings during the season. The Soling is at no more than 30% of these figures. This is why – considering also the state of the boat – the Committee has decided to to replace the Soling by buying a new Surprise. Next in the pipeline is to buy a new Yngling to replace the oldest of our most popular boats. We will discuss the case of the Catamarans at the General meeting. Thanks to Peter Brooks wehave revamped the Windsurf activity with new boards that were sailed by several enthusiastic members in Versoix and also in an outing on the lake Monteynard.

The Match-Race was an undeniable success. About forty members spent most of a windy and cloudy weekend in Versoix as crews, assistants or simple spectators. This was the apex of the Regatta season. Another novelty was the participation of Mic-Mac in a larger number of regattas, organized by other Clubs. We tried to find the right balance between the wishes of our racing fans and those of the other members that were competing for the use of the boat. The situation will hopefully improve next year with the new Surprise. We had some problems with the reservation of the boats that on a few occasions had not been booked in advance for the regattas. This calls for action.

A large proportion of the Club activities would have not been possible without the dedication of many members who spent part of their time on the Q-boat, to guarantee the safety of the courses, Thursdays and Club regattas. More than 75 members, almost 30% of the Club went out at least once on these safety shifts.

Versoix is our home-port and it is crucial to establish and maintain the best relationship with the port authority, the CNV and the Buvette staff. Gijs de Rijk was active on this "office" and we hope that in a renewed collaboration with our neighbors we can also improve on the situation of our moorings berths, especially the Yngling 10 that moors in too close contact with the First. We continued the traditional collaboration with the Cruising Club Suisse. We hosted their courses at CERN and organized for the second year a joint regatta in August. After the success of this second edition of the regatta, we jointly decided to make this a regular event of the two Clubs.




The boost of the LHC construction has an impact on our Club: our old "home place" near the ISR tunnel is needed for LHC activities and we have been moved to the so-called SPS point 5 or BA5. If you drive there today you will find near the gate – on the right when facing the gate - a shed, our dinghies and a container.

Chairman's Report (continued)

The "shed" is building 928. Shortly, it will be renewed with concrete floor, wooden walls, doors and windows. We hoped the works could start earlier to have our new place built before taking the fleet out of the water. This was not the case. Works are planned to be finished in winter. We will share this shed with the CERN scubadiving club

The place is very calm, near the woods. There is no surveillance on site, only a camera that checks the entrance. This poses some security problems that we are trying to solve by fencing off buildings 928 and 934.



Access with a car or outside working hours is possible only with a CERN card. We are discussing with the CERN security the possibility of providing a "CERN Club Member Card" to our non-CERN members. This will solve also the "old" problem of the YCC membership card where the Club has not been so efficient in the past.

An important change was made in our communication policy. The main communication tool of the club is now the electronic mail that can reach immediately more than 87% of our members. More than 40 e-mails were sent last year to the whole YCC-member list. The Committee enforces a strict policy limiting the use of this mailing-list to general club activities only. The "News" (4 publications) was distributed both electronically andby regular mail. Some 50 members receive it at home, on their request. The YCC-web site has been renovated and will be further renovated next year.

When preparing this document, I read again the letter I wrote to the YCC one year ago, when I intended to stand for Chairman. I wrote, "It is important that the Club work as a Club and that the Committee and the most active members feel to take part in - and not to be at the service of – the Community. Using again a well-known example: it is of fundamental importance for our Club to highlight with actions the difference between a Sailing Club and a boat rental steered by people with no skill for business. In the last years, this phase of renewal and strength was missing. Very few young and new members participate to the social life of the club and to its steering. Another aspect is that activities of the Club are the same (with very few exceptions) as when I arrived ten years ago. In the last two years I also missed a friendly and cooperative atmosphere inside the Committee. "

Looking back to my first year as YCC chairman, I conclude that we have made a good number of steps in the direction I wanted to head for one year ago. If this has happened, it was not because of me - it was tough for me to find for the YCC all the time that it deserves – but because I had a very efficient and dedicated Committee and because many of you have actively contributed to the life of the Club.

Jeûne Genevois Cruise

This year's JG Cruise took place from 2 to 16 September on the Greek side of the Ionian Sea. The scenery of the beautiful and picturesque island of Kerkyra (Corfu) was the backdrop to the starting point of the YCC flotilla.

The Club rented 5 yachts through Alcor Yachting, a Geneva-based broker representing the worldwide rental company Sunsail.

The price of the Cruise was 700 CHF/person/week for the rental plus 780 CHF for the optional flight. The difference between the price paid and the actual cost of the Cruise (which may vary, among others, depending on the type of boat and the number of participants) was returned to each crew in cash before the journey began. Robert's Sun Odissey 45.2 had a zero difference between the price paid and its actual cost.

All crews had a wonderful time and no incidents worth reporting occurred.

Next season, Robert Herzog will be in charge of organizing the JG Cruise.

Windsurf activity

With the recent acquisition of a complete new set of equipment, the YCC windsurfing section got off to a flying start. Courses for beginners were held until the end of the season and with the new modern equipment, the beginners quickly progressed towards obtaining the "W" license. A total of 16 sessions (8 weeks, twice a week) were held.

The new equipment consists of shorter, lighter and easier to handle boards permitting sailing in all but the lightest of winds and thanks to a good spread of sail sizes (4.1sq/m to 5.7sq/m) when the wind picked up sailing could continue. A large, buoyant beginner's board is also available when taking those first steps into the world of windsurfing.

An outing to Monteynard (near Grenoble) proved somewhat exciting, with Giovanni Cervelli realizing how important the choice of finn was when sailing in winds gusting Beaufort 7, and Roman Malina perfecting the "Grass Start" as a step towards his move into strong wind surfing.

Two licenses were issued during the season to club members. All the students on the course will be capable of taking the license at the start of the next season after demonstrating the ability to sail in a moderate wind. We only had very light winds near the end of the course preventing them from taking the test.

The income generated from the course fees is 600chf (6 students, 100chf per person) with an approximate cost of repairs/maintenance of 120chf before the boards are used next season.

Overall, all had a good season. Thanks must go to the people who helped out with the rescue cover (thankfully, we didn't have to use them too much!) Giovanni (for helping run the training) and Angela, Ans, Christine, Sandrine, Stefano and Roman for being such patient pupils.

Regattas.

This year, we tried to boost the Club from the racing point of view. This meant strong encouragement towards participation of club boats in external regattas (Geneve-Rolle-Geneve, Bol d'Or, Semaine du Soir in both Versoix and Rolle), as well as trying to improve the organization of our internal events.

We had five "standard" regattas, the classic "Traversee' du Lac", a two-day Match-Race tournament, reintroduced after four years and a joint YCC-Cruising Club Suisse regatta, that is now becoming a classic. In particular, the two latter events had a large success in participation.

From the organization point of view, we introduced the principle that boats are given to the skippers through a draw. We strived to publish the regatta results on the web the first day after the race, and on the CERN bulletin at the first available issue.

Next year, we plan to increase the participation to external events, organizing them well in advance, and to repeat both the Match-Race and the YCC-CCS joint event

Our Boats: Keelboats and Catamarans

Foreword

This year, Rob Veenhof joined the team to take care of our dear Surprise *Mic-Mac*. For the rest, all stayed as usual: the First and the Soling were in the capable hands of Michel Giroux and Claude Barnérias respectively. Unfortunately, Jan Borburgh is going to stop the maintenance of the Ynglings and after four years he will pass the task over to some new volunteer. Thanks, Jan, for all the effort you put in the care of our boats. Sven de Man, responsible for the catamarans, did not have much time neither for sailing nor for the maintenance and the *monsters* did suffer from that.

Account of the past season

Rob Veenhof accomplished an excellent refit of the Surprise. At the beginning of the season, Phil Durr overhauled the hull and with the subsequent work of Rob and new regatta sails we bought, the Surprise turned once again into a boat of which the club can be proud.

This season the Ynglings were finally equipped with new sails. Beside routine problems with the standing rigging (one of which forced Gigi to abandon the final regatta of the Match-Race) and a few other small things, there is nothing worth mentioning. A quiet season for the First and the Soling too, with nothing major to report.

The catamarans had instead a bad season. Several small problems kept often one or the other boat dry on shore. In some unfortunate occasions even both. There is also a major problem to report with *Mystère* 7; one of the hulls was badly damaged in circumstances which are still *mysterious*. This happened at the beginning of July and kept the boat on dock for the rest of the season.

Plans for next year

We have already asked your opinion about the catamarans in the last issue of the *News* of the year and any feedback you might wish to send to the Committee is still welcome. This will evidently influence heavily the activities related to those boats. As far as the Ynglings are concerned, we need to find a new person in charge of their maintenance, should any of you be interested, please contact the Committee! Discussions are still in progress about the enlargement and renewal of our keelboats fleet. Probably a "new" Surprise will be acquired and possibly one of the Ynglings will be replaced. When and if the new Surprise is purchased, the Soling will have to be withdrawn from service, due to the lack of mooring places in Versoix. We will keep you informed about that.

Our Boats: Dinghies

Foreword

Last winter, the maintenance of the dinghies was handed over from Udo Wagner to Enrico Bravin & Robert Herzog. We would like to thank Udo once more for the excellent job he did during the past few years and for the help he gave us to ensure a smooth transition. We would also like to thank all those who provided help during the season and hope you enjoyed sailing on *our* dinghies.

Account of the past season

Despite a slow start, due to logistical problems related to the reshuffling of the ISR area for the LHC era, the boats were made ready in time for the *launching of the fleet* on 15 April 2000. Unfortunately, the *mise à l'eau* coincided with the newly introduced *Easter cruise*, which deprived us of some experienced hands and resulted in an operation even more chaotic than usually, if that is imaginable.

The largest damage our boats had to suffer during the past season was the irreparably bent mast of our 470 *Susy* during the storm on 11 May. We had to order and rig a new mast, which left the boat out of operation for a few weeks.

Apart from this incident we encountered only a few problems with ripped sails and torn spinnakers, but nothing like what we saw at the last America's Cup!

The usual number of lost spinnaker poles and paddles contributed to the already large collection at the bottom of the lake. We will try to conceive a more efficient attaching system for the next season.

In August, we purchased new life jackets for all dinghies, sticking with the tried-and-tested model of the old ones. We hope that more care will be taken by all users in order to maximize their lifetime. Please *do not fold* the buoyancy providing cushions inside the jackets! Once folded the foamy plastic material will not return to its original shape.

Plans for next year

Since our dinghies are in quite good shape, we have no plans to replace any of them. We are going to consider the purchase of new sails (Iso, Lasers), to have some spare sails and to replace the oldest ones, which are already in a somewhat sad state. As far as we could observe, most users of the boats handled them carefully enough, but a *refreshment* of rigging and unrigging skills in a practical session might help all of us to better preserve our equipment. We are considering such a session in combination with the course activities.

At the the *sortie de l'eau*, we moved the boats to our new winter storage area close to the UA1 point of the SPS. We were promised to get a hangar-like building there before the end of the year. Once we will have moved in there, we will start the winter maintenance, for which we hope to find many volunteers among you! You'll hear from us!

Courses and Tests

Vincenzo Innocente and Rui Ribeiro were in charge of this year's sailing courses.

Many changes have been introduced. Courses and tests are now separate from each other: successful completion of a course no longer provides an automatic access to the corresponding license.

The Yngling course is now accessible to beginners. A dinghy license is no longer a requirement before sailing keelboats. Tests have been formalized and made more uniform: a general procedure has been put in place and published in the YCC news of July 2000. A general introduction to the Club facilities in Versoix was run the first Thursday of each month. Despite all these changes, courses were successful and several licenses been awarded.

We would like to thank the effort of all teachers and helpers who made all this possible. In particular, we wish to thank those who made the additional effort to volunteer as "tester" helping us in licensing 55 new sailors in the club this year.

Auditors' Report

We have audited the financial statements presented by the Committee and dated 1 October 2000, which have been prepared under the historical cost convention and normal accounting policies for not-for-profit societies, as in previous years. We draw the attention of the members to the fact that these statements are, exceptionally, for a period of 11 months rather than the usual 12 months. We agree with the Treasurer that it makes much sense to change the accounting year-end to this date, being after the time when major costs and revenues are incurred, whilst being early enough to allow time for adequate preparation and scrutiny prior to the Annual General Meeting in late November. In the latter respect only, we must declare an interest in the matter because our own task is thus easier.

We also draw the attention of the members to the suggested modification to Article 17 to be discussed in the next agenda item at the Annual General Meeting. This clearly has financial implications, and we feel bound to comment on it. In our opinion, the suggested modification would actually improve the security of members' funds compared to the *de facto* situation, whilst for the members to insist on the existing Article 17 being applied to the letter would significantly hamper the work of the Committee. The Committee in general and the Treasurer in particular are responsible for the preparation of the financial statements. It is our responsibility to form an independent opinion, based on our audit, on those statements and to report our opinion to you.

We conducted our audit in accordance with normal auditing standards. An audit includes examination, on a test basis, of evidence relevant to the amounts and disclosures in the financial statements. It also includes an assessment of the significant estimates and judgments made by the Committee in the preparation of the financial statements, and of whether the accounting policies are appropriate to the Club's circumstances, consistently applied and adequately disclosed. We planned and performed our audit so as to obtain all the information and explanations which we considered necessary in order to provide us with sufficient evidence to give reasonable assurance to the members that the financial statements are free from material misstatement, from whatever cause. In forming our opinion, we also evaluated the overall adequacy of the presentation of information in the financial statements.

In our opinion, the financial statements give a true and fair view of the state of the Club's affairs as at 1 October 2000 and of the increase in the Club's reserves for the period then ended and have been properly prepared in accordance with the Club's accounting policies.

Additionally, we feel bound to comment on an issue of concern to the Committee, which is correctly stated in the accounts but has future financial implications. We share the concern of the Committee that some CHF 14,120 of members' funds are passively locked in as Key Deposits. Our opinion is that the membership would be better served by following the advice of CERN's legal officer and setting a deadline for returning keys and refunding deposits, after which time any remaining Key Deposits could be transferred to General Reserves. Should the members decline this approach, we suggest the following alternative. That the entire Key Deposit fund be transferred to General Reserves and future key issues and refunds be treated as receipts and expenses for the current year. The total Key Deposit liability would be guaranteed by the value of the fleet and no attempt made to identify it separately. Finally, we advise the members that we are both prepared to accept re-election in this capacity, should the members so desire.
